I have attached the draft operating schedule document setting out the application and proposed activities, along with the proposed layout plans. Essentially the proposed application will be as follows;

Sales of alcohol (on and off sales) – Monday to Saturday from 10:00h until 23:30h and Sunday from 12:00h until 22:30h

Late Night Refreshment (indoors) – Monday to Sunday from 23:00h until 00:00h

Opening hours of the premises to the public –Monday to Sunday from 07:00h until 00:00h

Do note that the attached plans may be subject to some finessing prior to the submission of the application however, thought it would be helpful to send across to you so you can get a picture of the layout. We will ensure our client provides a compliant plan upon submission of the application.
